

Terms of Supply – Redlands Leucaena

Disclaimer

The following terms and conditions (**Terms**) govern the supply of seed products by Agrimix Pty Ltd ACN 159 796 399 or its authorised reseller (**Agrimix**) to you as the purchaser / user (**you**). It is important that you read and accept these Terms prior to purchasing Agrimix seed products. By purchasing this seed, you are deemed to have accepted and agreed to be bound by these Terms.

Terms

- 1. Agrimix grants you the right to plant this seed in accordance with these Terms.
- 2. When purchasing Redlands Leucaena from Agrimix, you acknowledge that it is a condition of supply that you will use your best endeavours to adhere to the Leucaena Code of Practice (Code) for best practice management for establishing and managing Leucaena pastures. A copy of the Code is attached to these Terms and can also be accessed at https://www.leucaena.net/the-leucaena-code-of-practice
- 3. You acknowledge that the performance of seeds purchased from Agrimix may be impacted by a number of factors, which are outside the control of Agrimix, including but not limited to:
 - (a) climatic conditions;
 - (b) soil composition;
 - (c) application methods; and
 - (d) farming practices.

Accordingly, you accept the risks associated with seed purchased from Agrimix, including any risk associated with the failure of the seed to perform in accordance with your expectations. To the extent permitted by law, Agrimix's liability for breach of any term implied into these Terms by any law is excluded.

- 4. You acknowledge that, except to the extent of any representations made by Agrimix in any current promotional literature, it remains your responsibility to satisfy yourself that the seed purchased by you is fit for its intended use.
- 5. To the fullest extent permissible at law, Agrimix is not liable for any direct, indirect, punitive, incidental, special or consequential damages including, without limitation, damages for loss of use or profits, arising out of or in any way connected with your use of this seed, whether based on negligence or otherwise.
- 6. The Australian Consumer Law may give you certain guarantees, which cannot be excluded in accordance with Items 3 and 5 of these Terms. Where liability for breach of any such guarantee can be limited, Agrimix's liability (if any) arising from any breach of those guarantees is limited to the replacement value of the seed or the cost of resupply or replacement of the seed, determined with reference to the transaction to which the breach relates.
- 7. Redlands Leucaena is covered by Plant Breeders' Rights Plant Breeders' Rights provide exclusive commercial rights and control over the materials, which they cover. Unauthorised commercial propagation and any sale, conditioning, export, import or stocking of propagating material is an infringement

- 8. under the *Plant Breeder's Rights Act 1994* (Cth) (**PBR Act**). Without limiting the application of the PBR Act you agree not to:
 - (a) harvest, modify, genetically manipulate or breed Redlands; or
 - (b) supply Redlands Leucaena to third parties for commercial purposes.
- 9. Notwithstanding any other provision of these Terms, if you chemically treat this seed, Agrimix accepts no responsibility, and will not be liable whatsoever, for any consequences that may be attributed to such treatment.
- 10. You acknowledge that Agrimix seed is not for personal, domestic or household purposes.
